WHEREAS, that the Town Board is the only agency with jurisdiction by law to undertake this action.

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of LeRay, New York:

1. Based upon the examination and consideration of the nature of the action and the emergency nature of the same, the Town Board determines the demolition constitutes a Type II action for purposes of SEQR and no further environmental review is required.

2. This Resolution shall take effect immediately.
